VII. Other Parks, Preserves and Lands

Mr. Svette reported that he is working with the Trust for Public Lands to acquire property through the Clean Ohio Grant around Coalburg Lake which is between Brookfield and Hubbard Townships. Copy of map is attached. Mr. Svette reported that there are 356 acres at the park site and a dam (24' x 200'). He stated that in the 2016 dam inspection report, there are items to be addressed. Mr. Svette stated that we would need a partner for cost sharing of this project, and he has approached the Hubbard and Brookfield Trustees.

Mr. Maas made a motion and seconded by Mr. Maas to approved Mr. Svette moving forward and exploring the possibly of acquiring the Coalburg Lake property through the Trust for Public Lands and Clean Ohio Grant as long as the following items are addressed:

1. No issues with the dam
2. House on small lot is removed
3. No water quality issues
4. No septic issues
5. No oil and gas issues
6. No environmental hazards
7. Review by the Parks' insurance carrier.

The motion carried.
